Your legacy can reflect what is most important and meaningful to you, and serve as an inspiration to your loved ones and your community.

The Hawai'i Community Foundation (HCF) can help you create a legacy gift that can support the well-being of the community you care about most.



What are some different ways to create your legacy?

A legacy gift with HCF enables you to dedicate financial resources to your favorite charities or causes, and to do so in a way that fits your lifestyle, your goals, and your family's financial situation. You can even create a permanent gift to charity that will also provide an income stream to you or your loved ones, often with tax benefits for you and your family. These are typically called planned gifts.

>> Retirement Plans

Naming HCF as a beneficiary of your IRA, 401(k) or 403(b) is a simple way to benefit the community while avoiding significant, often unanticipated, taxes.

>> Outright Bequests

You can make a bequest by including specific language in your will or living trust naming HCF as the recipient of a testamentary gift.

>> Charitable Trust

Giving through a trust provides financial benefits to you or a loved one, as well as the community.

>> Life Insurance

Including HCF as a beneficiary of a life insurance policy, or assigning policy ownership to HCF, can leverage small premium payments into significant community benefit.

What are the benefits of creating my legacy gift through HCF?

As a steward of charitable funds since 1916, HCF's Board of Governors and staff of more than 70 provide expert oversight of gift policies, asset management, and grantmaking.

Thanks to the generosity of legacy donors of all sizes through the years, HCF is currently able to provide \$30 million in grants each year from funds created through legacy gifts to support vital programs for the community.

With your support, HCF strengthens Hawai'i's nonprofit sectors as a cornerstone of civic society by:


- Developing locally based, permanent charitable funds for each island.
